1. This Invitation for Prequalification follows the General Procurement Notice (GPN) for this project that appeared in Development Business WB3182-06/14 of June 18, 2014
2. The Governments of Côte d'Ivoire, Liberia, Sierra Leone and Guinea have received financing from the World Bank, European Investment Bank, KfW Development Bank and the African Development Bank towards the cost of the Côte d'Ivoire - Liberia - Sierra Leone - Guinea Interconnection Project. Part of the proceeds will be used for payments under the contracts named above.

The TRANSCO CLSG ("the Employer") intends to prequalify Contractors and / or Firms for Contracts under financing of World Bank and European Investment Bank, for the multiple EPC:

- EPC-TL-WB/EIB-04-Lot1 : 225KV Transmission Line Yekepa (L) - Buchanan (L): Design, supply, installation, testing and commissioning, and repair any defects that may occur during the warranty period for the construction of 229 km of 225 kV line between Yekepa (L) - Buchanan (L) under WB financing;
- EPC-TL-WB/EIB-04-Lot2: 225KV Transmission Line Buchanan (L) - Monrovia (L) - Mano (L): Design, supply, installation, testing and commissioning, and repair any defects that may occur during the warranty period for the construction of 219 km of 225 kV line between Buchanan (L) - Monrovia (L) - Mano (L), under WB financing;
- EPC-TL-WB/EIB-04-Lot3: 225KV Transmission Line Mano (L) - Kenema (SL) - Bikongor (SL): Design, supply, assembly, installation, testing and commissioning, and repair any defects that may occur during the warranty period for the construction of 211 km of 225 kV between Mano (L) - Kenema (SL) - Bikongor (SL), under EIB financing;
- EPC-TL-WB/EIB-04-Lot4: 225KV Transmission Line Bikongor (SL) - Bumbuna (SL) - Yiben (SL): Design, supply, assembly, installation, testing and commissioning, and repair any defects that may occur during the warranty period for the construction of 219 km of 225 kV line between Bikongor (SL) - Bumbuna (SL) - Yiben (SL), under EIB financing;

It is expected that the invitations for bid will be made in **October 2015**.

3. Prequalification will be conducted through the prequalification procedures as specified in the World Bank's Guidelines: ***Procurement under IBRD Loans and IDA Credits, January 2011 (revised July 2014)***, and is open to all bidders from eligible source countries, as defined in the guidelines.
4. Interested eligible Applicants may obtain further information and inspect the prequalification documents at the address below, between 09h00 and 16h00 (local time, Monday to Friday). A complete set of prequalification document in English may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of **US \$ 150** or its **equivalent in Francs CFA** (at the exchange rate of the BCEAO the day of payment). The method of payment will be: certified check or confirmed bank transfer into the account of TRANSCO CLSG. The document will be sent by DHL to those who would like it, at their own expense. The purchase of the prequalification documents cannot be electronically. Applications for prequalification shall be submitted in English, with a translation of the legal documents. Only eligible candidates who bought the PQ documents will be allowed to compete.
