The Government of Rwanda represented by Rwanda Transport Development Agency (RTDA) has received funds from the African Development Bank, acting for the EU-Africa Infrastructure Trust Fund (EI-AITF), toward the cost of “Pipeline Road Project Studies”, as a component of the Multinational: Uganda/Rwanda: Busega - Mpigi and Kagitumba-Kayonza - Rusumo Roads Project. RTDA intends to apply part of the agreed amount for this grant to payments under the contract for the consulting services of detailed technical studies for the construction and asphaltting of Karongi-Gitwe-Nyanza and Gitwe Hospital-Ruhango road (86 km) road located in Districts of Karongi, Ruhango and Nyanza.

The services included under this project are the detailed technical study, including but not limited to detailed road engineering studies, economic appraisal, social and environmental impact, resettlement action plan, and preparation of tender documents. The duration of studies are of Ten (10) months including the required approval periods.

The RTDA now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.
