# Multinational Uganda/Rwanda: KIBUYE-BUSEGA-MPIGI AND KAGITUMBA-KAYONZA-RUSUMO ROAD PROJECT.

### **RWANDA:** CONSULTANCY SERVICES FOR CONSTRUCTION SUPERVISION OF REHABILITATION AND WIDENING WORKS OF KAGITUMBA-RUSUMO ROAD (208KM).

The Government of the Republic of Rwanda (GoR) has applied for financing from the African Development Bank (AfDB)<sup>1</sup> towards the cost for rehabilitation and widening works of Kagitumba-Kayonza-Rusumo road (208km); and intends to apply part of the agreed amount for the Loan to payments under the contract for Consultancy Services for supervision of rehabilitation and widening works of Kagitumba-Kayonza-Rusumo road (208km) and rehabilitation of milk collection centers and cross border market. The services included under this project are: (i) Design review to ensure correctness, completeness and compliance with nationally and internationally acceptable standards and update where necessary; (ii) Supervision of the works contract to ensure that the works comply with the approved design, drawings, specifications, conditions of contract and sound engineering practice; (iii) Preparation of final construction report and as built drawings of all completed works; (iv) Supervision of maintenance activities during the defects liability period and (v) And preparation of the project completion report (PCR). The works execution involved is grouped into lots as below;

**Lot 1:** Consultancy Services for rehabilitation and widening works of Kagitumba-Bugaragara-Gabiro road (60km) including rehabilitation of six (6) milk collection centers , ten (10) boreholes and a cross border market at Kagitumba for the duration of 26 months

**Lot 2**: Consultancy services for the Supervision for the rehabilitation and widening works of Gabiro-Kayonza road (56km) including rehabilitation of four (4) milk collection centers for the duration of 26 months.

Lot 3: Consultancy services for the Supervision for the rehabilitation and widening works of Kayonza-Rusumo road (92km) including a cross border market at Rusumo for the duration of 32 months.

Consultants are free to express interest in one or all the assignments. Consultants should clearly indicate the assignment (lot) they are expressing interest in and their order of

preference, but during the award of the contract a consultant shall not be awarded more than one to two lots contracts.

2. The Rwanda Transport Development Agency (RTDA) now invites eligible consultants to express their interest in providing the above mentioned services. Interested consultants must provide information indicating their qualifications for performing the services. Such information may include; (a) Brochures, (b) Description of assignments of similar nature conducted in the last 10 years, (c) Experience in similar conditions, and (d) Availability of appropriate managerial and technical skills among staff related to the assignment, etc). For each completed project, the Consultant shall provide the name and address of the client, start and completed dates, name(s) of lead and associate firms. To quality for short listing, a firm or association must have carried out a total of three (3) similar assignments for the last 10 years. Cited projects with insufficient information will not be considered. Consultants may form joint ventures to enhance their chances of qualification. A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method;

3. Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's "*Rules and Procedures for the use of Consultants*" May 2008 Revised July 2012, which is available on the Bank's website at http://www.afdb.org.
