- 1. This Invitation for Prequalification follows the General Procurement Notice (GPN) for this project that appeared in Development Business WB3182-06/14 Of June 18, 2014
- 2. The Governments of Côte d'Ivoire, Liberia, Sierra Leone and Guinea have received financing from the World Bank, European Investment Bank, KfW Development Bank and the African Development Bank towards the cost of the Côte d'Ivoire Liberia Sierra Leone Guinea Interconnection Project. Part of the proceeds will be used for payments under the contracts named above.

The TRANSCO CLSG ("the Employer") intends to prequalify Contractors and / or Firms for Contracts under financing of European Investment Bank and KFW, for the multiple EPC:

- EPC-SS- EIB/KFW-05-Lot1: Substations of Kenema (SL), Bikongor (SL) and Bumbuna (SL): studies, supplies, transportation to site, installation and testing the equipment of 225 kV substation of Kenema (SL), Bikongor (SL) and Bumbuna (SL) under EIB financing;
- EPC-SS- EIB/KFW -05-Lot2: Substations of Yekepa (L), Buchanan (L), Monrovia (Mount Coffee) and Mano (L): studies, supplies, transportation to site, installation and testing the equipments of 225 kV Substations of Yekepa (L), Buchanan (L), Monrovia and Mano(L), under KFW financing;

It is expected that the invitations for bid will be made in October 2015.
